
On January 5, 2010, the above listed individuals were arrested following the execution of a search warrant at 8 Vista Rossi Drive, Township of Oxford, Warren County, New Jersey. The search warrant was executed by the Bayonne Police Department, the Warren County Prosecutor's Office/Narcotics Task Force, the Washington Township Police Department Special Enforcement Team, the Drug Enforcement Administration Diversion Unit and the New Jersey State Police—Washington Barracks. During the execution of the search warrant, a marijuana growing facility was located inside the residence.

Both Kenneth Eisenhower and Roseann Eisenhower were charged with one (1) count of maintaining a CDS manufacturing facility, a first degree offense in violation of N.J.S.A. 2C:35-4, one (1) count of manufacturing marijuana, a second degree offense in violation of N.J.S.A. 2C:35-5a(1) and 2C:35-5b(10)(b), one (1) count of possession of more than 50 grams of marijuana, a fourth degree offense in violation of N.J.S.A. 2C:35-10(a)(3), one (1) count of child neglect, a fourth degree offense in violation of N.J.S.A. 9:6-3, one (1) count of possession of drug paraphernalia, a disorderly persons offense, in violation of N.J.S.A. 2C:36-2 and one (1) count of possession of a hypodermic needle, a disorderly persons offense in violation of N.J.S.A. 2C:36-6.

The first degree crime carries a maximum penalty of up to twenty (20) years in New Jersey State Prison and a fine of up to \$750,000. The second degree crime carries a penalty of up to ten (10) years in New Jersey State Prison and a fine of up to \$150,000. Each fourth degree crime carries a maximum penalty of up to eighteen (18) months in New Jersey State Prison. The possession charge carries a fine of up to \$25,000 and the Child Neglect charge carries a fine of up to \$10,000. Each disorderly persons offense carries a maximum penalty of up to six (6) months in jail and a \$1,000 fine.

Both Kenneth and Roseann Eisenhower were lodged in the Warren County Correctional Center in default of \$200,000 bail without a 10% option set by John J. Coyle, Jr., J.S.C.. First appearance before Warren County Superior Court Judge John J. Coyle, Jr. was held January 6, 2010 at 1:30 p.m. in Courtroom No. 1 of the Warren County Courthouse.

Please be advised that the defendants are presumed innocent of all charges unless and until proven guilty.
