On May 15, 2008, the Warren County Prosecutor's Office initiated an investigation involving additional missing funds from the Pollution Control Financing Authority, White Township, Warren County, New Jersey.

On July 11, 2008, complaints were filed charging the above-named individual with theft of funds during the time period of May 22, 1999 thru November 5, 2007 totaling in excess of \$213,000.00. It is alleged that while employed by the Pollution Control Financing Authority the above-named individual took cash monies intended for deposit with the Skyland's Bank. It is also alleged that during the time period in which these thefts occurred, the above-named individual falsified general financial ledgers.

Bail was set at \$150,000.00 with 10% by Honorable Edward Palmer of the White Township Municipal Court.

Criminal charges are merely accusations and the defendant is presumed innocent of all charges until and unless proven guilty.
