PRESS RELEASE

A search warrant was executed yesterday afternoon, Wednesday, April 18, 2007, at 130B Route 182, Hackettstown, New Jersey, as a result of an ongoing investigation conducted by members of the Warren County Prosecutor's Office/Multi-Jurisdictional Narcotics Task Force, New Jersey State Police and the Phillipsburg Police Department Special Operations Division. The Hackettstown, Mansfield and Independence Township Police Departments also assisted in the investigation.

Jonathan E. Emiliano was arrested without incident on warrants for three (3) counts of Distribution of a Controlled Dangerous Substance, Cocaine, within 1,000 feet of Hackettstown High School, in violation of N.J.S. 2C:35-7, a crime of the third degree; three (3) counts of

Distribution of a Controlled Dangerous Substance, Cocaine, less than one half of an ounce, in violation N.J.S. 2C:35-5a/2C:35-5b(3); three (3) counts of Possession with Intent to Distribute a Controlled Dangerous Substance, Cocaine, in violation of N.J.S. 2C:35-5a/2C:35-5b(3), a crime of the third degree; and three (3) counts of Possession of a Controlled Dangerous Substance, Cocaine, in violation of N.J.S. 2C:35-10a(1), a crime of the third degree. These crimes allegedly occurred between March 22, 2007, and April 10, 2007.

Additional charges were signed against Mr. Emiliano at the time of his arrest for one (1) count of Possession of a Controlled Dangerous Substance, Marijuana, with Intent to Distribute in a School Zone, in violation of N.J.S. 2C:35-7, a crime of the third degree; one (1) count of Possession of a Controlled Dangerous Substance, Cocaine, with Intent to Distribute in a School Zone, in violation of N.J.S. 2C:35-7, a crime of the third degree; one (1) count of Conspiracy to Distribute a Controlled Dangerous Substance, Marijuana, in the amount greater than one (1) ounce, in violation of N.J.S. 2C:5-2/2C:35-5b(11), a crime of the third degree and two (2) counts of Conspiracy to Distribute a Controlled Dangerous Substance, Cocaine, in the amount greater than one (1) half ounce, in violation of N.J.S. 2C:5-2/2C:35-5b(2), a crime of the second degree; and one (1) count of Possession of a Controlled Dangerous Substance, Marijuana, greater than one ounce, with Intent to Distribute, in violation of N.J.S. 2C:35-5b(11).

Mr. Emiliano is presently incarcerated in the Warren County Correctional Facility in lieu of bail. Bail was set by John H. Pursel, J.S.C., at \$150,000.00, no ten (10%) percent option. Mr. Emiliano made his first appearance before John H. Pursel, J.S.C., today, April 19, 2007, at 1:30 p.m. in the Warren County Superior Court.

Oscar J. Fuentes was arrested without incident on warrants for one (1) count of Possession of a Controlled Dangerous Substance, Cocaine, with the Intent to Distribute within 1,000 feet of Hackettstown High School, in violation of N.J.S. 2C:35-7, a crime of the third degree, one (1) count of Distribution of a Controlled Dangerous Substance, Cocaine, less than one half of an ounce, in violation N.J.S. 2C:35-5a/2C:35-5b(3); and one (1) count of Conspiracy to Distribute a Controlled Dangerous Substance, Cocaine, in the amount of less than one (1) half ounce, in violation of N.J.S. 2C:5-2/2C:35-5b(2), all crimes of the third degree. These crimes allegedly occurred on or about March 22, 2007.

Additional charges were signed against Mr. Fuentes at the time of his arrest for one (1) count of Conspiracy to Distribute a Controlled Dangerous Substance, Cocaine, in the amount greater than one (1) half

ounce, in violation of N.J.S. 2C:5-2/2C:35-5b(2), a crime of the second degree; and one (1) count of Possession of a Controlled Dangerous Substance, Cocaine, less than one half ounce, in violation of N.J.S. 2C:35-10a(1), a crime of the third degree.

Mr. Fuentes is presently incarcerated in the Warren County Correctional Facility in lieu of bail. Bail was set by John H. Pursel, J.S.C., at \$100,000.00, no ten (10%) percent option. Mr. Emiliano made his first appearance before John H. Pursel, J.S.C., today, April 19, 2007, at 1:30 p.m. in the Warren County Superior Court.

Providencia N. Martinez was arrested without incident on warrants for one (1) count of Conspiracy to Possession with Intent to Distribute a Controlled Dangerous Substance, Cocaine, in violation of N.J.S. 2C:5-2/2C:35-5b(3), a crime of the third degree, and one (1) count of Distribution of a Controlled Dangerous Substance, Cocaine, less than one half of an ounce, in violation of N.J.S. 2C:35-5b(3), a crime of the third degree. These crimes allegedly occurred on or about March 30, 2007.


Additional charges were signed against Ms. Martinez at the time of her arrest for one (1) count of Possession of a Controlled Dangerous Substance, Marijuana, with Intent to Distribute in a School Zone, in violation of N.J.S. 2C:35-7, a crime of the third degree; one (1) count of Possession of a Controlled Dangerous Substance, Cocaine, with Intent to Distribute in a School Zone, in violation of N.J.S. 2C:35-7, a crime of the third degree; one (1) count of Possession with Intent to Distribute a Controlled Dangerous Substance, Cocaine, in the amount greater than one half ounce, in violation of N.J.S. 2C:35-5b(2), a crime of the second degree; one (1) count of Possession with Intent to Distribute a Controlled Dangerous Substance, Marijuana, in the amount greater than one ounce, in violation of N.J.S. 2C:35-5b(11), a crime of the third degree; one (1) count of Conspiracy to Distribute a Controlled Dangerous Substance, Cocaine, in the amount greater than one half ounce, in violation of N.J.S. 2C:5-2/2C:35-5b(2), a crime of the second degree and one (1) count of Conspiracy to Distribute a Controlled Dangerous Substance, Marijuana, in the amount greater than one (1) ounce, in violation of N.J.S. 2C:5-2/2C:35-5b(11), a crime of the third degree.

Ms. Martinez was incarcerated in the Warren County Correctional Facility. Bail was set by John H. Pursel, J.S.C., at \$150,000.00, no ten (10%) percent option. Ms. Martinez made her first appearance before John H. Pursel, J.S.C., today, April 19, 2007, at 1:30 p.m. in the Warren County Superior Court.

Drug restraining orders were filed against all three defendants prohibiting them from going within 500 feet of 130B Mountain Avenue, Hackettstown, New Jersey. Also a total of \$1,600.00 and a 1998 Ford Explorer were seized at the time of their arrests.

The second degree crimes carry a maximum penalty of up to ten (10) years in New Jersey State Prison and \$150,000.00 in fines; and the third degree crimes carry a maximum penalty of up to five years New Jersey State Prison and \$150,000.00 in fines.

Please be advised that the defendants are presumed innocent of all charges unless and until proven guilty.
