On April 20, 2011, Peter Sloan, Jr., age 19, residing at 29 Sandpiper Drive, Allamuchy, New Jersey and Max Erroude, age 19 residing at 29 Sandpiper Drive, Allamuchy, New Jersey, were arrested after an undercover narcotics investigation conducted by the Warren County Prosecutor's Office Narcotics Task Force and the Hackettstown Police Department. The arrests resulted from the execution of a search warrant at the residence of Peter Sloan, Jr., and Max Erroude. The Warren County Tactical Team and the Hackettstown Police Department assisted with the execution of the Search Warrant.

Peter Sloan, Jr. is charged with one (1) count of unlawful possession of a controlled dangerous substance, specifically, adderall, a third degree offense in violation of N.J.S.A. 2c:35-10a(1), one count of possession with intent to distribute marijuana, a third degree offense, in violation of N.J.S.A. 2C:35-5a(1) and 2C:35-5b(11), one count of conspiracy to distribute marijuana in violation of N.J.S.A. 2C: 5-2 , N.J.S.A. 2C:35-5a(1) and 2C:35-5b(11), and one count of possession of drug paraphernalia in violation of N.J.S.A. 2C:36-2, a disorderly persons offense.

Max Erroude is charged with one (1) count of unlawful possession of a controlled dangerous substance, specifically, adderall, a third degree offense in violation of N.J.S.A. 2c:35-10a(1), one count of possession with intent to distribute marijuana, a third degree offense, in violation of N.J.S.A. 2C:35-5a(1) and 2C:35-5b(11), one count of conspiracy to distribute marijuana in violation of N.J.S.A. 2C: 5-2 , N.J.S.A. 2C:35-5a(1) and 2C:35-5b(11), and one count of possession of drug paraphernalia in violation of N.J.S.A. 2C:36-2, a disorderly persons offense.

Each third degree crimes carries a maximum penalty of up to five (5) years in New Jersey State Prison. Each fourth degree crime carries a maximum penalty of up to eighteen (18) months in New Jersey State Prison. Each disorderly persons offense carries a maximum penalty of six (6) months in the Warren County Correctional Center.

Peter Sloan, Jr., was lodged in the Warren County Correctional Center in default of \$25,000 bail with a 10% option. Max Erroude was lodged in the Warren County Correctional Center in default of \$25,000 bail with a 10% option. First appearances for both defendants will be before Warren County Superior Court Judge Coyle on April 21, 2011 at 1:30 p.m. at the Warren County Courthouse.

Please be advised that all defendants are presumed innocent of all charges unless and until proven guilty.
