Members of the Warren County Prosecutor's Office Sexual Assault and Child Abuse Unit and the Phillipsburg Police Department arrested the above named individual without incident Saturday, September 8, 2007 in Phillipsburg, New Jersey. The defendant was charged with six counts of first degree Aggravated Sexual Assault, seven counts of second degree Sexual Assault, one count of second degree Endangering the Welfare of a Child by engaging in Sexual Conduct which would impair or debauch the morals of the child, one count of third degree Aggravated Criminal Sexual Contact, two counts of fourth degree Criminal Sexual Contact, and one count of fourth degree Lewdness. The first degree charges carry a maximum sentence up to twenty years in the New Jersey State Prison, the second degree charges carry a maximum sentence up to ten years each in the New Jersey State Prison, the third degree charge carries a maximum penalty of five years in New Jersey State Prison, and the fourth degree charges carry a maximum penalty of eighteen months in New Jersey State Prison.


The charges allege that the defendant engaged in multiple acts of sexual penetration and sexual contact with a female while she was between the ages of 12 and 16 in Phillipsburg. The incidents occurred between September 23, 2002 and September 6, 2007. The defendant was acquainted with the victim.

The Honorable John J. Coyle, J.S.C., set bail at \$150,000.00. The defendant's first appearance was Monday, September 10, 2007 at 1:30

before the Honorable John H. Pursel, J.S.C. in Belvidere, New Jersey.
The defendant is currently in the Warren County Correctional Center in lieu of bail.

Detective Kristen Houck of the Warren County Prosecutor's Office Sexual Assault and Child Abuse Unit and Detective Scott Imboden of the Phillipsburg Police Department conducted the investigation.

Please be advised that the charges are merely accusations and that the suspect is presumed innocent until and unless proven guilty.
